This protest includes, but is not limited to, the expenditure of any funds used in the disciplining of clergy who provide spiritual support and services to GLBTQi people as they would to non-GLBTi people. We therefore request that the Treasurer of our Annual Conference publish to the website an accounting of any financial or other resources that are expended in any of the discriminatory practices identified above, when such practices are identified by any member of our Annual Conference. Further, we request that our Annual Conference Secretary send correspondence to the other Annual Conferences advising them of our actions and encouraging them to take similar action."
